A donation of publicly listed securities allows you to support healthcare excellence at the QEII Health Sciences Centre and take advantage of the elimination of capital gains tax on the donated securities.

Please note: The value of your donation receipt will be based on the closing bid price on the day the securities are received in the QEII Foundation's account through our custodian.
